The correct use of Incoterms® rules is essential for the successful movement of goods between customers and suppliers around the globe. Getting them wrong can lead to delays, penalties, problems with payment and unhappy customers. However, importers must ensure that they are aware of the rules and obligations of the Customs Regime they wish to avail themselves of, as well as the admin burden to the Importer, and strictly adhere to the procedures.
